## **Research Faculty Position in Community Engaged Research Northwestern University, Feinberg School of Medicine**

The Feinberg School of Medicine at Northwestern University announces a research faculty position to begin in Fall 2022, in community-engaged research. Community-engaged research centers collaboration with community stakeholders to co-design, conduct, and disseminate research that benefits health and equity. Community engagement is a major area of study and practice for translational scientific research at Feinberg and a strong interest of many Chicagoland community stakeholders and Feinberg students. We are particularly interested in applicants whose work addresses any of the following priorities as we seek to add to our strong portfolio of existing community engagement research and practice:

- Science of community engagement
- Using and testing innovative strategies for engaging community stakeholders and expanding collective action
- Anti-racism and social justice (Structural factors and social determinants that affect community health including community assets and power as well as racism and policies and social structures, such as residential segregation, that have created racial inequities in education, healthcare, criminal justice, social services, and other areas)
- Implementation science

This is a non-tenure-track faculty position at the rank of Research Assistant/Associate Professor for candidates whose work focuses on community-engaged research. The new faculty member will be based within Northwestern's Center for Community Health (CCH) (<https://www.feinberg.northwestern.edu/sites/cch/>), which leads efforts to promote and study community-engaged research throughout the institution. CCH brings together collaborative, multidisciplinary teams of scholars and community members to improve health in underserved communities through a shared commitment to health equity, innovation, and translational research.

The new faculty member will collaborate on research projects throughout the institution and Chicagoland that are seeking to integrate community engagement principles and practices, provide consultation to research teams and community stakeholders on community-engaged research and stakeholder engagement, and contribute to the training and education missions of CCH and the medical school. Additionally, the faculty member will be encouraged to develop their own independent research portfolio, with priority given to faculty working in the areas of maternal mental health and early childhood development, cardiovascular health, food allergy, and the science of community engagement. There are opportunities for teaching and leadership roles within the community health research concentration in Northwestern's Program in Public Health (<https://www.feinberg.northwestern.edu/sites/cehs/our-programs/program-in-public-health/index.html>), and candidates should also emphasize experience teaching and mentoring graduate students, if applicable.

The ideal candidate will have a history of working with patients and community stakeholders in developing, implementing, and sustaining clinical and translational research, deep understanding of principles of community-engaged research, demonstrated record of increasing equity, diversity, inclusion and anti-racism, experience with grant/proposal development for extramural funding, and writing for peer-reviewed publication and community audiences. We recognize that each candidate may not bring expertise in all these areas. A PhD or MD (or foreign equivalent) in a health-related field is required.

The faculty member's academic appointment will reside in a Department within the Feinberg School of Medicine appropriate to the individual's training. This position will report to Dr. Darius Tandon, CCH Director.

To apply, please submit a cover letter, the names and contact information of three references, a CV, and three writing examples. Writing examples may include peer-reviewed publications, media works, and opinion pieces. At least one writing sample should be a peer-reviewed article broadly related to science or practice of community-engaged research and one writing sample should use lay language—for example, an example of sharing findings with community audiences or communications with project stakeholders. CCH community stakeholders will be part of the interview process. Letters of recommendation may be requested at a later date.
